

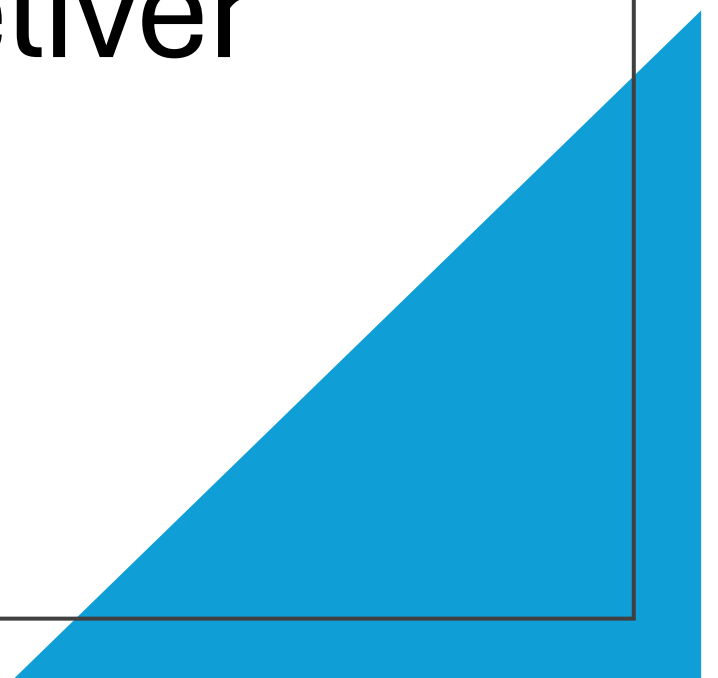

Key Developments



Market Shaping: Investing in Our Care Sector - Implementing a new 10-year Care & Wellbeing (Homecare), Supported Living Frameworks to build stable workforce to enable delivery of excellent outcomes focused care with technology enabled care core to the new provisions.



Learning & Development – Working with Sheffield Hallam University to deliver TEC learning and a virtual house in collaboration with the TEC Services Association.



Early Help – Building our falls prevention programme as a partnership with Yorkshire Ambulance and our City Wide Care Alarms Services and a range of tests of change including medication management.



Co-Design: Investing in our PA Workforce – Implemented a Direct Payments and Personalisation Strategy with a key aim of enabling individuals to have the choice and control in how they wish their care to be delivered to meet their outcomes.
